### Initial Surrogate Program Costs

<b>Surrogacy Program – Agency Expenses</b>	<b>\$28,750</b>
<ul style="list-style-type: none"> <li>➤ Surrogate matching, including rematches in the event a new Surrogate is needed</li> <li>➤ Coordination of journey, including insurance, IVF, medical billing, Surrogate’s travel</li> <li>➤ Create &amp; maintain Trust Account, distribute periodic statements</li> <li>➤ Intended Parent psychosocial support throughout journey</li> </ul>	
<b>Surrogacy Program – Legal, Screening, and Support Expenses</b>	<b>\$9,750</b>
<ul style="list-style-type: none"> <li>➤ Social Work screenings for Surrogate and partner, including rematches</li> <li>➤ Criminal history and background checks for Surrogate and partner</li> <li>➤ Enrollment of all surrogates in Social Work Support Program for Surrogate</li> <li>➤ Intended Parents’ legal fees for Surrogate Agreement (including rematches)</li> </ul>	
<b>Third Party Expenses and Contingencies</b>	<b>\$4,200*</b>

<ul style="list-style-type: none"> <li>➤ Estimated Surrogate reimbursement for first time surrogate, not in high demand state (\$30,000), monthly misc. expenses (\$3,000)</li> <li>➤ Estimated expenses for first transfer, including travel expenses (\$2,500), transfer payment (\$750), standard local monitoring (\$3,000)</li> <li>➤ Estimated expenses for singleton pregnancy, including maternity clothing (\$500), post birth recovery and housekeeping (\$1,600)</li> <li>➤ Insurance Policy to cover Surrogate bedrest (\$1,150)</li> <li>➤ Includes allowance of \$4,000 for contingencies in Surrogate Agreement</li> </ul>		
<b>Intended Parent Legal Rights</b>		<b>\$7,500*</b>
<ul style="list-style-type: none"> <li>➤ Estimated cost for legal proceedings to establish Intended Parents' rights</li> </ul>

### Program Options – Chosen by Signing Addendum & Paying Funds

<b>Twins Program</b>	<b>\$7,500</b>
<ul style="list-style-type: none"> <li>➤ Circle will provide a match with a Surrogate approved for carrying twins who has approved maternity insurance (thereby avoiding the need to use a Lloyds of London Primary plan which has a \$30,000 deductible (excess) for a twin pregnancy and delivery)</li> <li>➤ This program does NOT cover the children’s expenses in the hospital, Intended Parents must have own approved insurance to cover children in hospital to choose this program option</li> <li>➤ If twin pregnancy achieved, Intended Parents will pay additional expenses outlined in Additional Payments Based on Circumstances section below</li> </ul>	
<b>Fixed Fee Program</b>	<b>\$9,750</b>
<ul style="list-style-type: none"> <li>➤ Fixed fee for all Surrogate compensation and expenses, including reimbursements to Surrogate, travel expenses, contingencies, etc.</li> <li>➤ Local Monitoring at Approved Clinics</li> <li>➤ Fixed price for all legal work, including local counsel and filing fees to establish Intended Parents’ rights in the US</li> <li>➤ IPs also pay fixed price of \$26,000 for all maternity insurance and medical expenses, life insurance and complications insurance for retrievals and transfers</li> </ul>	
<b>Concierge Program</b>	<b>\$17,250</b>
<ul style="list-style-type: none"> <li>➤ All program benefits of the Fixed Fee Program, plus the following:</li> <li>➤ Program Manager will serve as Concierge, the Intended Parents’ sole point of contact for communication both internal and external to Circle</li> <li>➤ Coordination of Intended Parents’ travel, if requested</li> <li>➤ Assistance with Creation of Intended Parents’ matching profile</li> </ul>	
<b>VIP Program</b>	<b>Upon Request</b>
<ul style="list-style-type: none"> <li>➤ All program benefits of the Concierge Program, plus the following, if requested:</li> <li>➤ Circle to attend important appointments in-person</li> <li>➤ Enhanced legal assistance after delivery, including in-person support</li> <li>➤ Assistance with obtaining short term housing for Intended Parents</li> <li>➤ Assistance arranging professional photography for maternity and newborn photos</li> <li>➤ Additional benefits and gifts provided to Surrogate throughout journey</li> </ul>

### Additional Payments Based on Circumstances

<b>Estimate for Additional Transfer or Mock Cycle</b>	<b>\$6,850</b>
<ul style="list-style-type: none"> <li>➤ Includes additional transfer fee for surrogate (\$750), monthly misc. expenses (\$600), estimate costs for travel (\$2,500) and local monitoring (\$3,000)</li> <li>➤ Included in fixed fee program</li> </ul>	
<b>Potential Higher Carrier Reimbursement</b>	<b>\$5,000+</b>
<ul style="list-style-type: none"> <li>➤ Higher Reimbursement for Carrier in High Demand States (\$5,000)</li> <li>➤ Higher Reimbursement for Experienced Carrier (\$5,000+ each previous journey)</li> <li>➤ Higher Reimbursement for Carrier in SPAR program (varies)</li> </ul>	
<b>Estimate for Single Child's Expenses in Hospital</b>	<b>\$2,000 - \$5,000</b>
<ul style="list-style-type: none"> <li>➤ Estimated expenses for single child in hospital</li> </ul>	
<b>Estimate for Twin Pregnancy</b>	<b>\$12,000 - \$17,500</b>
<ul style="list-style-type: none"> <li>➤ Higher reimbursement to Surrogate and Agency</li> <li>➤ Higher Bedrest insurance premium</li> <li>➤ Higher contingency fund to pay for Surrogate expense, including maternity clothing, post-birth recovery expenses, c-section fee</li> <li>➤ Flat fee of \$15,000 if in fixed fee program</li> </ul>	
<b>Estimated Expense if Egg Donor Needed</b>	<b>\$27,250</b>
<ul style="list-style-type: none"> <li>➤ Includes fixed Agency Fees for Egg Donor Program</li> <li>➤ Includes estimated legal, screening and support expenses for Egg Donor Program</li> <li>➤ Includes estimated Egg Donor expenses at time of match</li> </ul>	
<b>Other Potential Expenses (Contingencies negotiated in Carrier Agreement)</b>	
<ul style="list-style-type: none"> <li>➤ Additional Compensation for local counsel for birth orders/adoption (\$2,000+)</li> <li>➤ Expenses for pumping payments &amp; supplies (if IPs request) (\$2,000)</li> <li>➤ Companion Travel Expenses (varies)</li> <li>➤ Fees paid to Surrogate for Caesarean section (\$2,500)</li> <li>➤ Fees paid to Surrogate for abortion or selective reduction (\$1,000)</li> <li>➤ Fees paid to Surrogate for amniocentesis, CVS, cerclage, surgical D&amp;C procedure, surgical removal of ectopic pregnancy (\$500 each)</li> <li>➤ Fee paid to Surrogate for loss of reproductive organ (\$3,000)</li> </ul>
